School Board Meeting Minutes Griswold Community Schools Monday, October 17, 2022

The Board of Education met for its regular meeting on Monday, October 17, 2022 in the Conference Room. - Discussion On Board Of Directors Redistricting Henrichs reviewed the potential situation in which the School district would need to redistrict their board of director districts. After consulting with the school's attorney and the lowa Department of Education, there is no need to redistrict our board of director districts, however the board will have to pass a resolution stating such. No formal action taken.
