

NOTICE IS HEREBY GIVEN TO THE ELIGIBLE VOTERS OF CASS COUNTY, IOWA, THAT THE COMBINED CITY & SCHOOL ELECTION WILL BE HELD ON TUESDAY, NOVEMBER 2, 2021.

The polls for said election will be open from 7:00 A.M. until 8:00 P.M.

Voters must vote in their precinct of residence. Please read this notice carefully to determine your correct voting location. Voting location has changed for some voters. If your are unsure of your voting precinct for this election, please contact the Cass County Auditor/Commissioner of Elections (Phone; 712-243-4570). *NOTE: This is a COUNTY-WIDE election. Every eligible voter in Cass County is eligible to vote. City residents will vote for both city and school candidates and measures; and rural residents will vote for school candidates and measures only.*

Persons who have changed their name and/or address within Cass Co. will be required to re-register at the polls before being permitted to vote. Pre-Registration for persons to vote in this City/School Election closes at 5:00 P.M. Monday, October 18, 2021. Same day registration and voting is permitted.
